

#### Eligibility for application (Applicants must meet the following criteria)

- As of the day before the announcement date, foreign residents who have lived in Korea for over a year, including workers, married immigrants, international students, and Korean compatriots aged 18 or older and have lived in Busan for over 90 days. - Recommended by at least ten domestic and foreign residents, 18 or older, with supporting signatures or nominated by organizations related to foreign support such

as non-profits, legal organizations, public institutions, etc. X Only those who are legally registered (and in good-standing) under the Republic of Korea's Immigration Control Act and be able to communicate (a good amount) in Korean.

## □ Preferences

 $\times$  Meets at least one of the following:

- Those with intermediate or higher Korean language skills
- Those with excellent documentation and computer skills
- Those with Busan residency status or work experience in Korea
- Those with experience in foreign community activities, award recipient in related fields, etc.
- Those with proficient in English

### □ Disqualification

% The selection may be canceled if a criminal history is discovered or committed during the selection or activity period

- Those family court has judged the commencement of adult guardianship due to a lack of ability based on mental restrictions caused by illness, disability, old age, etc.

- Those sentenced to imprisonment and execution has terminated or two years have not elapsed from the date of exemption from execution

- Those sentenced to suspended imprisonment and in the grace period
- Those with two years of a sentence which still needs to be served.
